**VOTING RESULTS AT ANNUAL GENERAL MEETING
HELD ON 5 JUNE 2025**

At the annual general meeting of Arts Optical International Holdings Limited (the “Company”) held on 5 June 2025 (the “AGM”), a poll was demanded by the Chairman for voting on all the proposed resolutions as set out in the Notice of AGM dated 28 April 2025 (the “Notice”).

As at the date of AGM, the total number of issued shares in the Company was 386,263,374 shares, which was the total number of shares entitling the holders to attend and vote for or against the resolutions at the AGM. There was no share entitling the holder to attend and abstain from voting in favour at the AGM as set out in rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”).

No shareholder of the Company was required under the Listing Rules to abstain from voting on the resolutions at the AGM. None of the shareholders has stated their intention in the Company’s circular dated 28 April 2025 to vote against or to abstain from voting on any of the resolutions at the AGM.
